5G upgrade of of the Vodafone element of the installed telecommunications infrastructure including replacing three antennas positioned behind the existing GPR louvres with six antennas, replacing one cabinet located in the church basement with three cabinets, installing a GPS module to the inner north parapet wall, installing 12 ER units to the walls of the bell chamber and works to tidy cabling along the floor to give better access to the bell. All in accordance with Net CS drawings numbered 128784_02 - 600A, 601B, 602B, 603A, 604A, 605B, 606A, 607B, 608A, 609A, 650B, 651A, 652A, 653B, 654A, 700B, 701B, 702A and structural report by JB Towers Ltd dated 2nd March 2022.

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
